1.2 Course aims and learning outcomes

The aim of the course is to provide students with foundational knowledge and sound understanding of what is migration, what classifications of migration exist and what are recent trends in the field, to introduce students to theories and challenges of Migration, to orient students to proceed with field research on the basis of received knowledge. This course examines international migration from both theoretical and empirical perspectives to provide students with an understanding of the factors behind current trends in international population movements and their impacts on the migrants themselves and the countries of origin and destination.

The course pursues the following **objectives:**

- 1. To introduce the theoretical approaches to research in the field of migration.
- 2. To introduce current trends in international migration.
- 3. To demonstrate historical developments of the migrations in different regions.
- 4. To orient students to the more detailed research of the issue.
- 5. To explore the potential of the international migration.

Learning outcomes:

By the end of this course students should be able to:

- Demonstrate an understanding of the issues related to current trends and patterns in international population movements in different countries and regions;
- Discuss the policy implications of international migration trends and patterns and critique policy recommendations based on the theoretical and empirical perspectives on international migration examined in the course.
